Unlike the larger District and County Councils, the Parish Council of Glenfield does not receive funding from Central Government or Business Rates. Instead, the net cost of our services is entirely supported by the council tax payers of Glenfield. This year, the portion of your council tax that funds the Parish Council has been adjusted in line with the Consumer Price Index as of Autumn 2024, increasing by 1.6%. As a result, an average band D household will now pay £110.00 annually, representing a modest increase of £1.15.

The Parish Council plays a vital role in representing Glenfield's interests to external bodies and collaborates with the District Council, County Council, and other agencies to enhance and supplement local government services within Glenfield. We are consulted on all planning applications pertaining to Glenfield properties and submit written representations.

Parish Council meetings are open to both the press and the public, with details publicized on our notice boards and website — www.glenfield-pc.gov.uk. There is an opportunity for public members to share comments or queries. It is advisable to contact us before attending to ensure we are better prepared to assist you.

Services provided or subsidized by the Parish Council include:

- Floodlit Multi-sport facilities at Ellis Park
- Leisure amenities within Millennium Green
- Ellis Park Bowling Green
- New Public Convenience at Ellis Park (expected by Spring 2025)
- Christmas lighting and festive events, including the Annual Picnic in the Park and VE Day 80th celebration
- Maintenance of Ellis Park and Station Park
- Hanging baskets and planters
- Brantings Park Wildlife Meadow & Jubilee Wood
- Allotments on Main St and Mill Lane
- Secure Dog Exercise Areas at Mill Lane & the Sports ground
- Subsidised sports facilities at Glenfield Sports Ground
- Gynsill Meadow Woods and Pond
- Subsidised community use of the Park House/Sports Pavilion and The Annexe

Additionally, we oversee open spaces such as Barley Close Greens, Blackthorn Green, Peartree Green, Wheatfield Pond, Wollaton Green, Normandy Green, and Watersmeet Meadow.

We are committed to addressing climate change. Initiatives include planting over 100 trees and shrubs, utilising battery-operated machinery to reduce carbon emissions by minimizing reliance on external contractors. Our facilities have been retrofitted with LED lighting to decrease energy consumption and CO2 emissions significantly.

By incorporating recycled materials for our notice boards and street furniture, we reduce the demand for virgin materials, thereby avoiding the greenhouse gas emissions associated with their extraction or mining.
